Old Testament




Lev 25:25 If one of your countrymen becomes poor and sells some of his property, his nearest relative is to come and redeem what his countryman has sold.

28 But if he does not acquire the means to repay him, what he sold will remain in the possession of the buyer until the Year of Jubilee. It will be returned in the Jubilee, and he can then go back to his property.

Lev 25:47 If ... one of your countrymen becomes poor and sells himself to the alien living among you or to a member of the alien's clan,


48 he retains the right of redemption after he has sold himself. One of his relatives may redeem him:

49 An uncle or a cousin or any blood relative in his clan may redeem him.







- 4. Willing to redeem


Kinsman Redeemer Concept


